#### Introduction

Thank you for the opportunity to submit on the Waikato Regional Councils proposed Plan Change 1.

My name is Cliff Babington. Along with my wife leonie I have farmed this farm, originally 479 acres, up to 870 acres at one time, and now 550 acres, for the last 50 years. During this time we have planted 30 hectares in trees, introduced deeper rooting grass species, increased fertility, sub-divided paddocks from 16 to 60 by contour fencing, installed a water reticulation system and increased both production and animal health levels. We feel we have achieved this with minimal impact on the environment and the farm is now far less fragile. As the demands changed we have farmed or are still farming; sheep for wool, prime lambs, prime beef, bull beef, export onions, maize for grain, heifers and cows for the dairy industry. It is our hope that our children and their children will continue farming this farm.

Our strategy is to leave the farm in better health than when we purchased it.
