I oppose the proposed Waikato Regional Plan Change 1.

I farm 500 ha at Piopio in the Waitomo District. My farm is made up of 3/4 rolling and 1/4 steep hill country, split in half by the Mangaotaki River, on which I only run sheep.

I do not put in any crops or work up any ground. I use no nitrogen and only use slow release non water soluable Dicalcic Fertilizer. I am able to farm this way now because my debt is very low. Because I do not farm intensively I dont need to employ anyone.

My son hopes to take over the farm one day. To be able to do this he will have to borrow a substantial amount of money. In order to service the debt he will have no option but to farm more intensively.

Before that, if my health deteriorates or I get injured and am unable to run the farm by myself I will need to employ someone. To be able to afford an employee I would have to farm more intensively.

Another option would be to lease the farm out, but no one would be interested in leasing the property unless they could farm it more intensively.

Even though my property is not in the Waikato River catchment and will not be effected by the proposed Waikato Regional Plan Change 1, I am very concerned with the effect it will have on people farming in the Waikato River catchment, and in other catchments in the future.

If this plan change was to become law in the Mokau catchment , I would have to consider intensifying my farming system before the legislation is passed.

My farming system is most probably the least polluting in the area, and yet I would be the most disadvantaged by the proposed plan change. It seems to me that the proposed plan change will do nothing to encourage existing non polluting farmers to remain that way.

The proposed plan change 1 disadvantages the least polluting farmers the most, to the extent that they will effectively be subsidising the most polluting farmers, which is very, very wrong.
