#### **MY SUBMISSION IS THAT**

We oppose this plan as it would drastically impact on our farming operation both physicially and financially. It removes any certanity in to future of farming this block for ourselves and our family and effectivly make this property valuess as a farm. This property was part of a larger block and had been created to form a homestead and 85 acre property which has successfully been farmed since the creation of this block. The whole block has been successfully farmed for over 100 years and has proved sustainable for many generations. This is now under serious threat by the proposed plan.

It appears that there has not been any scientific research or evidence gained that this proposal would in fact benefit the overall outcome (Swimmable Rivers), and all it does is impact on the lives and incomes of ourselves and many people in similar circumstances.

There appears to have been little or no actual researce into the discharges from individual properties over many varied types of country here in the Waikato and instead a "broad brush" plan has been proposed to the region. A"one size fits all "type of plan which is simplistic and totally unacceptable. This being a smaller property and with limited stock carrying ability, minimum fertilising and higher husbandry had been lumped in with larger and differing types of farm.

Our property has had much time money and love spent on it and this shows when or if someone actually visited it. There are 3 small creeks flowing through our property whish are normally less than a metre wide and 300cms deep, several ponds on the property have all been fenced and are heavily planted therefore any runoff is "minimal". Altoughh we are a hill country farm this is grazed both symathetically and with good husbandry and has relatively low stock numbers. There appears No rationale in the plan to totally exclude Stock from Hill country, apart from averything else it would turn the country into a giant fire hazard without cattle grazing this country.

The requirement of Scedule 1 to supply a FEP is in our view both unneccesary and unacceptable for both cost and effort.
